

GBUZ IC Clinical Cardiological "Regional Dispensary" is the only cardiological dispensary in the Stavropol Territory, it is a large medical, consultative and diagnostic institution of the cardiological service of the Stavropol Territory and the North Caucasus Federal District. As part of the implementation of the regional project "Fight against cardiovascular diseases", the cardiodispanser is assigned the role of a leading organizational and methodological center, organizing and coordinating the implementation of project activities to achieve targets for reducing mortality and mortality from diseases of the circulatory system in the region, increasing the life expectancy of Stavropol residents.

The dispensary is headed by the chief physician, cardiologist of the highest qualification category, Candidate of Medical Sciences - Irina Viktorovna Terentyeva.

The bed capacity of the cardiology dispensary has 144 beds, including 25 cardiac surgery, 94 cardiology, 9 intensive care and 16 beds in a cardiology day hospital working in two shifts. The consultative and polyclinic department is designed for 170 visits per day. Diagnostic assistance is provided for functional, ultrasound diagnostics, radiation and laboratory diagnostics. The Department of Gravitational Blood Surgery and Hyperbaric Oxygenation uses hemocorrection, efferent therapy, quantum hemotherapy and HBO in the treatment of patients.

The cardiodispanser employs more than 280 employees, including 68 doctors, 106 average medical workers. The team of doctors consists of 29 cardiologists, 3 cardiovascular surgeons, 3 doctors for X-ray endovascular diagnostics and treatment, 10 anesthesiologistsresuscitators and doctors of other specialties.

6 employees are candidates of medical sciences, 3 are Honored Doctors of the Russian Federation and 20 are excellent healthcare professionals.

The dispensary is the clinical base of the departments of Stavropol State Medical University and Medical



College, which allows the staff of the institution to increase the level of knowledge by interacting with leading Russian and foreign medical clinics.

The cardiological dispensary uses the most advanced methods of diagnosis and treatment of cardiovascular pathology, surgical treatment of coronary artery disease and cardiac arrhythmias.

In the midst of a pandemic, the cardiology dispensary continues to provide planned and emergency care to the population in full. The new threat required new organizational solutions. All modern means of communication and telemedicine are used to accompany patients.

In 2021, 45077 visits were made by patients to the doctors of the consultative polyclinic department, 3769 patients were treated in round-the-clock hospitals, 949 in day care. 1439 coronary angiography, 649 coronary artery stenting, 691 EX implantation and 86 radiofrequency ablations were performed. More than 100 telemedicine consultations with Federal Medical Centers have been conducted. For emergency consultations of regional patients, doctors of the cardiological remote consultation point with the tele-ECG function have made almost 1000 ECG interpretations.

Residents of the region and the entire North Caucasus Federal District have completed 4012 programs of pacemakers of all types implanted both in the dispensary and in federal clinics of the country.

Over the past 3 years, such surgical interventions as cryoisolation of the mouths of the pulmonary veins of the

left atrium with atrial fibrillation using second-generation balloons, stenting of the coronary arteries with 1-3 stents, coronary thrombextraction, radiofrequency ablation of atrial fibrillation using endocardial echocardiography, implantation of an EX with the installation of an electrode in the area of a bundle of Gis.

Medical assistance to foreign citizens temporarily staying or permanently residing in the Russian Federation is provided in the GBUZ IC "KKCD" in accordance with the Decree of the Government of the Russian Federation dated 06.03.2016 No. 186 "On approval of the rules for the provision of medical care to foreign citizens in the territory of the Russian Federation":

- foreign citizens who are insured persons in accordance with the federal law "On Compulsory Medical Insurance in the Russian Federation" have the right to free medical care within the framework of compulsory medical insurance;

- medical assistance to foreign citizens, as a rule, is provided in accordance with contracts for the provision of paid medical services, or voluntary medical insurance contracts.

The dispensary accepts cardiac patients from CIS countries for diagnosis and treatment. We work according to international standards of treatment and can guarantee that each of our patients will receive high-quality necessary

medical care in the shortest possible time.

We provide our patients with a personalized individual approach in the treatment of cardiac diseases. At the same time, our patient is from countries
